About AGLF

The Association for Governmental Leasing & Finance (AGLF) is a nonprofit corporation recognized under Section 501(c)(6) of the Internal Revenue Code of 1986, for the purpose of improving business conditions in the municipal leasing and financing industry. For over 40 years, the AGLF has offered unmatched education and networking opportunities for professionals active in the municipal leasing and financing industry.

AGLF members are active in all types of public finance transactions (taxable and tax-exempt governmental and conduit / nonprofit leases, bonds, certificates of participation, etc.) and include lenders, municipal advisors, placement agents, investment bankers, underwriters, government officials, vendors, manufacturers, captives, brokers, commercial bankers, lawyers, trustee and escrow agents, rating agencies, bond insurers, and more.

The AGLF holds an annual member meeting and conference, generally held in the first two weeks of May. AGLF conferences are structured to further the mission of the organization. Conferences serve as an educational forum to promote discussion of current topics of member interest, noteworthy industry developments, changes in laws and best practice, and current and future economic and market conditions. Conference planners and leaders in the industry, and presenters/speakers include industry and subject matter experts. The conference's opening cocktail reception, group breakfasts, lunches and dinners, and the sponsored evening entertainment also provide attendees amazing networking opportunities with fellow municipal market participants.

Membership Categories

Governmental/Non-Profit Organization (\$450)

This category is designed for a single professional employed by any state or political subdivision, or federal government entity, or non-profit entity. This category of membership includes access for one person to the AGLF newsletter, member conference registration rates, the membership directory, member alerts and member support from the AGLF and its management company.

Individual Membership (\$850*)

This category is designed for one professional with his or her own business, or one professional in a larger organization (for example, one lease broker, placement agent, municipal advisor, or service provider), where such person is the only professional in the organization actively participating in the municipal leasing and financing industry. This category of membership includes access for one person to the AGLF newsletter, member conference registration rates, the membership directory, member alerts and member support from the AGLF and its management company, PLUS the annual AGLF industry survey.

Corporate Membership (\$1,750*)

This category is designed for up to three individuals from a single organization actively participating in the municipal leasing and financing industry. Many service providers (for example, law firms, rating agencies, trust-ees and escrow agents, ESCOs, etc.), municipal advisors and smaller lenders join this membership category. This category of membership includes access for three people to the annual AGLF industry survey, the AGLF newsletter, member conference registration rates, the membership directory, member alerts and member support from the AGLF and its management company. IN ADDITION, the three members will receive access to the AGLF's proprietary member resources: (1) the 50-State Survey of State Laws,

(2) the Federal Tax Law Summary, and (3) the Federal Securities Law Summary. AGLF webinars may be purchased separately.

Executive Membership (\$3,000*)

This category is designed for up to six individuals from a single organization actively participating in the municipal leasing and financing industry. This category of membership includes access for up to six people to all of the benefits of the Corporate Membership, PLUS free access to all AGLF webinars.

Leader Membership (\$5,000*)

This category is designed for an unlimited number of individuals from a single organization actively participating in the municipal leasing and financing industry. This category of membership includes access for an unlimited number of people to all of the benefits of the Executive Membership, PLUS free access to all other resources prepared from time to time by the AGLF for Leader Members only. Such resources may include industry training materials for new hires, additional surveys of relevant state laws, etc. More importantly, since Leader Members are committed to ensuring that AGLF and the industry remain strong and vital, organizations in this category will receive regular acknowledgement on the AGLF website and in most AGLF materials.
