MEMBERSHIP CATEGORIES

Individual & Governmental/Not-For-Profit Organization Membership (\$450) This category of membership is designed for a single professional who owns their own business or works for an organization that is eligible to finance projects on a tax-exempt basis. This category includes a single professional employee, lease brokers or attorneys, and government or not-for-profit organization employees.
